Matters Arising from 2017 AGM

There were no matters arising.

The minutes of the 2017 AGM were reviewed and read out by Ellie Brown, and accepted.

Treasurer's Report

Kehinde submitted a written set of accounts.

The deficit was mainly due to an accurate stock take being carried out since last year's accounts. Financially it was the second most successful in the club's history (after 2014 and receipts from the BMAF champs at Sidcup.)

Expenses similar to last year, with British League being slightly higher due to further distance travelled to venues.

There was a discussion stemming from club subs as to whether club vests are still to be given away to new members for free or if we start charging. This is to be discussed by Committee.

Ellie relayed a question from Len Reilly via e-mail as to whether the accounts had been audited. The last two years' accounts have now been audited, and this year's will, but are not yet.

Ellie thanked Kehinde on behalf of the club for his nine years' service in the post of Treasurer since he is now standing down.

Membership Report

Barny asked whether we could include junior events in the schedule and would be happy to help with organising this.

Dan Pettitt asked why it was on a Sunday this year and whether this could be looked at? The date this year clashed with a football game, and also next year's date has been provisionally booked.
